Let me begin with John Donne's famous poem to Group Analysis written in 1624.

No man is an island, entire of itself; every man is a piece of the continent, a part of the main. If a clod be washed away by the sea, Europe is the less, as well as a promontory were, as well as if a manor of thy friend's or thine own were: any man's death diminishes me, because I am involved in mankind, and therefore never send to know for whom the bell tolls; it tolls for thee.



Observing it in my work I can conclude that the nation prefers group therapy to individual one: a group gives possibility for an individual to survive (4. A society allows its members to achieve needs or wishes they could not fulfil alone.); it actualizes defensive mechanisms of the split, escape; the fact of uniting into groups becomes a «training ground» for acting out of the deportation trauma. The fact of the appearance of the group actualizes “the recollection” of the trauma –the deportation and the experience of the traumatic survival in the ethnic group.
